1.SUBMISSION GUIDELINES FOR TINI 2025 SCIENTIFIC AWARDS EMAIL

Abstracts consist of three (3) categories to choose from: Case Report, Research, and Literature Review.

Abstracts must be written in **English**, following the **TINI 2025 Scientific Awards abstract guidelines**, and submitted to the committee's email:

The **email subject** must follow this format: Category1_Category2_FullName_Institution

Explanation:

- Category 1: Short Lecture/ Poster
- Category 2: Case Report/ Research/Literature Review

2.TINI 2025 SCIENTIFIC AWARDS ABSTRACT WRITING GUIDELINES

Important notes:

- The abstract may not exceed 250 words.
- The main text must be written in Microsoft Word format, with 12 points Times New Roman font, single space with justified margins and 25 mm margins on all sides.
- The file must be converted into PDF format before submission.
- The manuscript writing should refer to the international guideline for medical journal. Further information can be found at https://www.equator-network.org/ and http://www.icmje.org/

FORMAT OF ABSTRACT FOR LITERATURE REVIEW

TITLE

Authors Name Affiliation

Corresponding Author: Name, Affiliation, Email and Phone

ABSTRACT (Sectioned: Background, Objectives, Methods, Results, Conclusion, Keywords)

Background:

• Concise, should explain the rationale for the review in the context of existing knowledge

Objective:

• Provide an explicit statement of the main objective(s) or question(s) the review addresses.

Methods:

• Provide eligibility criteria, information sources, risk of bias, and synthesis of results.

Results:

- Give the total number of included studies and participants
- Summarize relevant characteristics of studies and present results for main outcomes, preferably indicating the number of included studies and participants for each.
- If meta-analysis was performed, report the summary estimate and confidence/credible interval.
- If comparing groups was performed, indicate the direction of the effect (i.e. which group is favored).

Conclusion:

• Discuss the implications of the findings and suggest future research directions.

Keywords:

Provide five relevant keywords in alphabetical order, separated by comma, refer to MeSH term.



Mandatory:

Declaration of interest

Public trust in the scientific process and the credibility of published articles depend in part on how transparent conflict of interest are handled during the planning, implementation, writing, peer review, editing, and publication of scientific work.

Authorship

The authorship is based on the following 4 criteria:

- 1. Substantial contributions to the conception or design of the work; or the acquisition, analysis, or interpretation of data for the work; AND
- 2.Drafting the work or revising it critically for important intellectual content; AND
- 3. Final approval of the version to be published; AND
- 4.Agreement to be accountable for all aspects of the work in ensuring that questions related to the accuracy or integrity of any part of the work are appropriately investigated and resolved.

Originality

Article must be **original** and never been submitted to any events or publications. Plagiarism and AI generated writingare prohibited and will be disqualified.

References

The manuscript may have about 50 references. Reference Book and a chapter in an edited book maximum 10% from all references.

3.PRESENTATION AND POSTER GUIDELINES FOR TINI 2025 SCIENTIFIC AWARDS

GUIDELINES FOR LITERATURE REVIEW PRESENTATION

- The presentation should be written in **English**.
- The presentation must be made in Power Point Presentation (PPT) format.
- The presentation time for **literature review** should not be more than **7 (seven) minutes.**
- Timetables for each presentation will be provided in advance of the TINI 2025 congress.
- All presenters must attend the entire sessions they are allocated to, 15 (fifteen) minutes prior to the event schedule.

GUIDELINES FOR ELECTRONIC POSTER (E-POSTER)

Important Notes:

- Save your poster as a **PDF format** in a 55-inch LCD screen size (length70 cm x height 123 cm).
- The poster must be submitted in its **final version**, editing after submission is not permitted.
- Posters will be displayed electronically on LCD screens (E-Poster) and do not need to print.
- Timetables for each electronic poster presentation will be provided in advance of the TINI 2025 congress.
- All presenters must attend the entire sessions they are allocated to, 15 (fifteen) minutes prior to the event schedule.



THE CONTENT OF THE ELECTRONIC POSTER (E-POSTER):

- The e-poster should be written in **English**.
- Tittle of the e-poster is on the top center and **should be identical** to the submitted abstract.
- The logo of TINI 2025 is placed on the top left corner, the author's institution logo is placed on the top right corner, and the first author's photo is placed below the institution logo. You may download the logo of TINI 2025 on Scientific Awards Section of TINI 2025 web.
- Names and affiliations of all authors (each author to be marked with superscript Arabic number in example 1, 2) must be written along with their corresponding institution affiliation and their addresses followed by corresponding author's email.
- The presenter's name should be **BOLD**, identified with an asterisk (*).
- Consider the selection of font type, size, and colour and make sure your poster could be read from **2-meter distances**.
- Make sure that any photographs of figures, graphs and tables in the poster are of sufficient sizes.
- Content of poster presentation:
 - a. **Case Report:** Background, Objective, Case Report, Conclusion and References
 - b. **Research and Literature Review:** Background, Objective, Method, Result, Conclusion and References
- At the **footer** part of poster presentation should be noted: "Displayed at: TINI 2025, November 21st -23rd 2025".
